# PANEL MEETING 3

26 March | Lyric Hammersmith | London

The third Panel meeting was held at The Lyric Hammersmith, where Nick Kenyon and the Commissioners were hosted by the Head of Tri-Borough Music Hub, Stuart Whatmore. We were also joined by Matt Griffiths (CEO, Youth Music), and Kathleen Williams (Executive Headteacher) and Anna Lewis (Music teacher and Creative Director), who both work across several Tri-Borough schools.

Our guests opened the meeting by discussing the various activities to support progression within their own organisations, before focusing on the opportunities, challenges and potential solutions for better supporting progress across music education. Key issues raised included a lack of understanding about the importance of early years provision; an increased need for better connections between Hubs, schools and teachers; a change in the ways that music meets the needs of young people; and the development of a more innovative and diverse workforce in music education.

The discussion proceeded to look at the many areas of possible focus for the Commission. These included pedagogical training, practical support for teachers and organisations and developing plans for supporting individual expression and creativity.

After a brief update on the current research programme, Panel members were invited to lead focus groups with their own communities as a contribution to the Commission's public consultation. The meeting concluded with a look forward, led by Daniel Harris of DHA Communications, who will be tasked with gathering the findings towards the final report.

The next Panel meeting is Monday 25 June.
